Subject: Law Enforcement Services

Scope: Renew the Town of Index (Town) law enforcement services contract for another three years. Minimum staffing under the contract is one *on duty* deputy to patrol both the unincorporated and incorporated areas of the Town.

The County's responsibilities under this contract are:

- Reactive Patrol – respond to calls on an as needed basis.
- Proactive Patrol – 15 minutes/day proactive patrol of the town.
- Investigative services for crimes.
- Special services that may include K-9 patrol, hostage negotiations, Special Weapons Response Team (SWAT), bomb disposal, sex offender registration, dive team, reserve deputy support, volunteer, and community crime prevention.
- Support services including planning and research, subpoena control, training, accounting, payroll, and other administrative support services.
- The SCSO Public Information Officer will prepare news releases pertaining to major crimes.
- Records/data entry into RMS system.
- Maintenance of evidence collected as part of an investigation with the Town.

The Town's responsibilities under this contract are:

- Confer municipal police authority on County deputies.
- Provide criminal justice system services as needed.
- Supplies, stationery, notices, forms, equipment, etc.
- Obtain access to SERS.

Duration: January 1, 2024, through December 31, 2026

Fiscal Impact: Current Year Multi-Year N/A

Annual Fee paid by the Town to the City is depicted in the table below. For calls for service: 2024 \$120.83/per call; 2025 \$126.26/per call; and 2026 \$131.95/per call.

If direct costs to the County increase more than 1% over the amount of anticipated inflation included in Addendum 1, the parties will renegotiate compensation terms based on actual direct cost.
