

**AMENDMENT 4 TO THE SOFTWARE AS A SERVICE AGREEMENT WITH  
LEGALATOMS CORPORATION**

**RECITALS**

WHEREAS, Snohomish County and LegalAtoms are the parties to that certain Software as a Service Agreement (the “Agreement”) for an Online Protection Order System, executed on September 23, 2020, as amended on February 3, 2021, September 30, 2021, and July 25, 2023; and

WHEREAS, the County wishes to add payment collection services offered by LegalAtoms, which provides users to pay Anti-Harassment fees to the County electronically.

**AGREEMENT**

NOW, THEREFORE, for and in consideration of the mutual benefits conferred on both parties, the parties agree the as follows:

1. Exhibit D, Payment Processing Scope of Work is hereby attached to this Amendment 4 and by this reference incorporated into to the Agreement.

## EXHIBIT D

### Payment Processing Statement of Work

- 1. Electronic Payments for Anti-Harassment Protection Orders (AHPO):** LegalAtoms shall provide Snohomish County residents with a PCI compliant option to securely pay fees for Anti-Harassment Orders via debit or credit card:
  - a. LegalAtoms collects fees using Stripe
  - b. LegalAtoms shall maintain PCI compliance and provide proof of compliance to County annually or upon request.
  - c. The PCI compliant payment processing service shall be provided to the County at no cost
  - d. LegalAtoms shall pay fees collected to County weekly by direct deposit. In accordance with RCW 43.09.240, the parties agree that the Snohomish County Treasurer has granted an exception that daily transfers would not be administratively practical or feasible.
  - e. County shall be able to download deposit reconciliation reports
