

**AMENDMENT 9 TO THE WEBSITE DEVELOPMENT AND HOSTING AGREEMENT  
WITH CIVICPLUS, LLC f/k/a ICON ENTERPRISES, INC**

This is Amendment 9 to the Website Development and Hosting Agreement, dated July 22, 2013, as amended by Amendment 1 dated May 4, 2015, and Amendment 2 dated October 19, 2016, Amendment 3 dated May 24, 2019, Amendment 4 dated December 22, 2021, Amendment 5 dated May 12, 2022, Amendment 6 dated July 14, 2022, Amendment 7 dated August 26, 2022, and Amendment 8 dated January 25, 2023 (together, hereafter "The Agreement"), by and between Snohomish County, a political subdivision of the State of Washington (the "County"), and CivicPlus, LLC, f/k/a Icon Enterprises, Inc., a limited liability company organized under the laws of the state of Kansas ("CivicPlus") (CivicPlus and County collectively, the "Parties" and each a "Party").

Whereas, Civic Resident and Community Engagement continues to be a core priority for Snohomish County government and thus a key strategic initiative for Snohomish County IT; and

Whereas, the County desires to acquire and implement CivicPlus Chatbot, an artificial intelligence (AI) tool for use on its website; and

Whereas, the increased cost to the Agreement for CivicPlus Chatbot implementation and subscription fees from January 1, 2026 through July 31, 2026 shall not exceed Nine Thousand Seven Hundred Ninety-One Dollars and Sixty-Seven Cents (\$9,791.67) plus applicable sales tax.

NOW, THEREFORE, in consideration of the promises and covenants set forth in this Amendment 9, and for good and valuable consideration, the sufficiency of which is acknowledged, the Parties agree that the Agreement shall amended as follows:

1. Exhibit I, Chatbot Statement of Work is added to the Agreement to describe the services added by this Amendment 8 and incorporated herein by this reference.
2. The Annual CivicPlus Service Fees table in Exhibit B, Compensation, is amended to read as follows:

2. This Chatbot Statement of Work ("SOW") shall be subject to the terms and conditions of the Agreement, dated July 22, 2013, to which this SOW is hereby attached as the Chatbot Statement of Work as well as the Chatbot terms and conditions in section 6 of this SOW.
3. The Initial Term for this SOW shall be effective on January 1, 2026 and shall align with the Agreement current Term end date of July 31, 2026.
4. By signing this SOW, Client expressly agrees to the terms and conditions of the Agreement, as though set forth herein.
5. Upon signing and submitting this SOW, Client will receive the applicable invoice according to the terms of the invoicing schedule outlined in the Agreement
6. Chatbot Terms and Conditions

The Customer understands that the Chatbot Services are not intended to collect, and CivicPlus discourages the Customer from soliciting and collecting, any personally identifiable information ("PII"), protected health information ("PHI"), payment card industry information ("PCI") or any other financial data from its users. CivicPlus cannot monitor and control the Customer's actions; therefore, in the event the Customer solicits and stores any personally identifiable information ("PII"), protected health information ("PHI"), payment card industry information ("PCI"), or other financial data, it is at the Customer's sole discretion and risk. The Customer as the data owner, and not CivicPlus, is solely responsible for the applicable laws and regulations regarding any data breach involving such data, including breach notification and credit monitoring requirements.

The Customer understands that the Services must crawl over the Customer's entire site and scrape information for successful performance. The Customer shall be solely responsible for obtaining permission from any third party whose content may be crawled and/or scraped by the usage of the Services. In no event shall CivicPlus be liable to the Customer or any third-party, for any claim, action, liability, or damages, arising out of or related to the Services crawling over and/or scraping any third-party system and/or content. The cost of the Services listed in the applicable SOW is for one domain, limited to ten crawled websites, if the Customer requires more domains or crawled websites, the Customer should reach to the Customer's designated CivicPlus representative. CivicPlus and Frase, Inc. shall have the right to collect and analyze data and other information relating to the provision, use, and performance of various aspects of the Services and related systems and technologies (including, without limitation, information concerning the Customer data and data derived therefrom), and CivicPlus and Frase, Inc. will be free (during and after the term hereof) to:

1. use such information and data to improve and enhance the Services and for other development, diagnostic and corrective purposes in connection with the Services and other CivicPlus offerings, and
2. disclose such data solely in aggregate or other de-identified form in connection with its business. No rights or licenses are granted except as expressly set forth herein.

CivicPlus shall not be responsible or liable for the content of messages created by the Customer, or by end-users who access the Service.
