Subject: Interlocal agreement for Local Health Officer coverage between the

Washington State Department of Health (DOH) and Snohomish County

<u>Scope:</u> The interlocal agreement allows a Dr. Herbert Duber to serve as the acting Local Health Officer (LHO) in Snohomish County in the case of the

LHO's absence or incapacitation.

Dr. Herbert Duber is a Regional Medical Officer with Washington State Department of Health in Region 4, which includes Snohomish County. DOH requires Regional Medical Officers¹ to meet the same qualifications

as LHOs as established in RCW 70.0².

In accordance with RCW 70.05.0808³ and SCC 2.300.080⁴, an acting health officer may be appointed by the Snohomish County Executive with the consent of Council. Acting LHOs are approved by Council by motion.

The acting LHO will have the same duties, powers, and authority as a regularly appointed LHO and will act in accordance with applicable law

and under the direction of the Board of Health.

<u>Duration:</u> The interlocal agreement term is from execution through one calendar

year. The parties may extend the term by written agreement.

<u>Authority Granted:</u> Ordinance 24-019 authorizes the County Executive, or a designee, to execute an interlocal agreement substantially in the form of Exhibit A with the Washington State Department of Health for Local Health Officer coverage.

Background: On June 7, 2023, Council approved Ordinance 23-039⁵ authorizing the County Executive to execute an agreement with Whatcom County for LHO coverage when one of the officers is absent.

Requested Action: Move to GLS on April 3, 2024, to set time and date for Public Hearing.
