Proposal: Motion 21-375 Date: October 20, 2021

Consideration:

The proposed motion would authorize the County Executive to execute Amendment No. 1 to the software as a service (SaaS) agreement between Snohomish County and Rave Wireless dba Rave Mobile Safety for emergency response notification services.

Background:

In February of 2020 Snohomish County entered into a Software as a Service Agreement ("Agreement") with Rave Wireless for the agreed to new integrated notification system (Motion 20-030)¹. Snohomish County selected Rave Wireless, through RFP-11-19SB, following established Federal, State and County policies to provide an "out of the box" 24 hour a day, 7 days a week support that would integrate with existing County public safety systems Sno911 and Smart911 with minimal configuration.

Snohomish County and Rave Wireless now wish to amend the Agreement to include one additional SMS to Opt-in a keyword to support Airport operations and public safety. The amendment would begin November 12, 2021 and allow the Airport one additional "keyword" feature for alerts to tenants, travelers, and other stakeholders in the community of unsafe or emergency situations and/or conditions.

Current Proposal:

Scope: The proposed Amendment No. 1 to the Master Contract will allow for an additional Rave Keywords feature to be added to the software licenses and support.

Duration: The term of this amendment is from November 12, 2021 to February 11, 2025.

Fiscal Implications: The total amount payable under this amendment agreement is \$4,875 for Amendment No. 1.
