- ▶ A) Total FTE count listed are permanent and funded. In 2022 we have added 38.2 FTE.
- ▶ B) The department is currently recruiting for 15 permanent FTE. All positions are funded.

2023 Budget Questions

1. How many FTEs do you have that are working remotely, fully, or partially?

All staff have been equipped with telework capable devices. Daily, approximately 70% of the Rucker Building staff are working remotely. Leadership developed mitigation measures for clinical and non-clinical staff. Clinical staff are required to wear masks while interacting with patients/clients. The District has a small COVID team working remotely to assist with LTCF, childcares, and schools.

2023 Budget Questions

1. Please describe how much CARES/ARPA funds your department has requested or received in 2022 and 2023, and the utilization of those funds.

2022 CARES Funding received through DOH was \$5,691,480 2023 ARPA Funding requested amount of \$710,948

The funds for 2022 received from DOH are utilized for COVID-19 Response activities (e.g., incident management for response, case investigation, contact tracing, testing, care coordination, surge management, data reporting, and isolation & quarantine etc.)

The fund for 2023 requested from the County will be utilized for disease investigators and data analysis around COVID in addition to adding support to public records request related to COVID.
