Heidi Beazizo, Chief of Staff, provided a staff report and explained that this ordinance would authorize the Executive to sign five interlocal agreements with the cities of Arlington, Everett, Mukilteo, Lynnwood, and Lake Stevens for 2023 County/City Partnership Projects. She said the total REET II investment is \$320,000 and each investment per city is included in the staff report [linked at 2023-1161]

ACTION: Councilmember Low made a motion to set time and date for Wednesday, December 13th at the hour of 10:30 a.m for Ordinance 23-110. Councilmember Peterson seconded the motion and it carried unanimously.

c. Ordinance 23-134, granting a non-exclusive franchise authorizing limited use of the public road rights-of-way in portions of Unincorporated Snohomish County, Washington to Northshore Utility District

Deb Bell, Sr. Legislative Analyst, provided a staff report and explained details of the proposed franchise.

ACTION: Councilmember Low made a motion to set time and date for Wednesday, December 13th at the hour of 10:30 a.m for Ordinance 23-134. Councilmember Peterson seconded the motion and it carried unanimously.

d. Amended Motion 23-450, related to the 2023 Budget; approving a transfer of budgeted contingency from Non-Departmental to County Offices and Departments within General Fund 002

Jim Martin, Sr. Legislative Analyst, provided a staff report and explained the necessity for the budget transfer.

ACTION: Councilmember Low made a motion to approve Substitute Motion 23-450. Councilmember Dunn seconded the motion and it carried unanimously.

e. Motion 23-497, approving award of Workforce Project Funds 2023-1289 (Workforce Snohomish)

Jim Martin, Sr. Legislative Analyst, provided a staff report. He stated the contract is through December 31, 2024, with a not to exceed amount of \$1,500,000.00.

ACTION: Councilmember Low made a motion to approved Motion 23-497. Vice-Chair Nehring seconded the motion and it carried unanimously.

f. Motion 23-502, authorizing the Chair of the Council to sign certification of 2024 tax levy estimates

Jim Martin, Sr. Legislative Analyst, provided a staff report and explained the tax levy certification process.

ACTION: Councilmember Low made a motion to approve Motion 23-502. Councilmember Dunn seconded the motion and it carried unanimously.

g. Ordinance 23-130, approving amendment to Whatcom County contract for Youth Cannabis & Commercial Tobacco Prevention Program

Heidi Beazizo, Chief of Staff, provided a staff report. She explained this ordinance would approve Amendment 4 to the contract with Whatcom County to continue the Cannabis & Commercial Tobacco prevention program and increase the funding by \$45,000, bringing the total for the contract period to \$142,928 and extending the contract period to June 30, 2024.

ACTION: Councilmember Low made a motion to set time and date for Wednesday, December 13th at the hour of 10:30 a.m for Ordinance 23-130. Councilmember Peterson seconded the motion and it carried unanimously.

She said the term of the agreement is September 1, 2023, through August 31, 2024, with a one year extension allowed. The total of the agreement is \$75,000, with \$29,000 anticipated costs this year.
