**Authority Granted:** Approve and authorize the County Executive to sign Change Order CO-01 to bid PW-24-028SB for the Kitchenette Construction of the New Start Center of Edmonds with Lincoln Construction, Inc., and would authorize the Executive to approve future change orders for additional work provided that there is sufficient appropriation authority, and the future total contract additional work does not exceed \$667,641.00, which is 20% of the total of the original contract plus Change Order CO-01.

The 2024 Housing and Behavior Health Capital Fund Investment Plan (Motion 24-417) requires County-owned property, capital contracts and subsequent amendments where the aggregate total of the contract and amendments total more than \$150,000 shall come to Council for approval by motion. Contracts below this amount may be approved by the Executive or designee.

**Background:** Snohomish County purchased the America's Best Value Inn (Edmonds) in 2022. The County has been bringing effected areas up to code for future habitation.
