Background: The original contract amount of \$60,000.00 is authorized to date. Amendment 9 adds the funding needed to correct the overspend and adds funding for the remainder of 2024 through 4/9/2025 for an additional funding total of \$550,000.00 to complete the contract through the end date of 4/9/2025. The new contract Not to Exceed is \$610,000.00 for Mechanical Door & Gate Maintenance Services.
