Background: The ordinance approves Amendment No. 2 to the Interlocal Agreement with the City of Bothell for road improvements to 228th St SE from 35th Ave SE to 39th Ave SE. The amendment adds design, right-of-way and acquisition services to the agreement in order to purchase the parcels necessary for the project. The amendment also includes additional authorization for Public Works in the amount of \$1,019,313 to complete the work. The term of the agreement is from execution through completion. At the Public Hearing, the Council may consider amendments to the proposed ordinance.
