Summary: The ordinance approves an Interlocal Agreement (ILA) with the Tulalip Tribes of Washington relating to the transfer of 64th Street NW. Snohomish County Public Works currently maintains 64th Street NW as part of the County road network. The Tribes wish to improve and maintain 64th Street NW as a public road as part of the Tulalip Tribes Tribal Transportation Program. This ILA will allow the transfer of real property rights for 64th Street NW from the County to the Tribes and relieves the County of future costs associated with maintaining 64th Street NW.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
