A summary of the proposed ordinance is as follows:

#### PROPOSED ORDINANCE NO. 079

### AN ORDINANCE APPROVING THE ACCEPTANCE OF A STATUTORY WARRANTY DEED AND ESTABLISHING A NEW PORTION OF 28<sup>th</sup> Dr SE

Section 1. Adopts findings of fact.

Section 2. Finds that SSHI LLC, dba D.R. Horton intends to deed property described in Section 3 for the use of the public in perpetuity by statutory warranty deed.

Section 3. Provides the full legal description of the right-of-way and establishes 28th Dr SE as County Road right-of-way subject to the conditions in Section 7.

Section 4. Requires SSH I LLC, dba D.R. Horton to construct the road to County design standards at its own expense and to post a two-year maintenance security.

Section 5. Finds that 28th Dr SE is a public necessity, is practicable, and the public will be benefited by its establishment.

Section 6. Authorizes the County Executive to accept the deed on behalf of the County.

Section 7. Provides conditions before establishment becomes effective.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
