Subject: Right-of-Way plan for 84th Street NE & 123rd Avenue NE Intersection Safety Improvements; RC1790; UPI#22-0013.

Scope: The proposed Right-of-Way plan would allow Public Works the ability to construct a roundabout at the 84th Street NE / 123rd Avenue NE intersection to improve traffic flow and safety. This is project D.67.02 of the adopted 2024 ACP and 2024-2029 TIP. The motion would approve the necessary appraisal contracts and acquisition of impacted property necessary to implement the plan. Property from eleven parcels is to be acquired, with the Right-of-Way acquisition process scheduled to occur in 2024 and 2025.

Fiscal Impact: Current Year Multi-Year N/A

Funding has been secured through a Highway Safety Improvement Program (HSIP) federal grant and a Rural Arterial Program (RAP) state grant.

Authority Granted: Approves and authorizes the County Executive to execute the Right-of-Way Plan for 84th Street NE & 123rd Avenue NE Intersection Safety Improvements Project, and authorizes the Public Works Director to approve appraisals and appraisal review contracts necessary to implement the plan in the amount not to exceed \$84,000, provided sufficient appropriation authority exists, and authorizes the County Engineer to acquire uneconomic remnants or additional impacted property, and authorizes the County Engineer to revise the plan and to approve and sign a revised Right-of-Way Plan to provide for design revisions and to document uneconomic remnants or additional impacted property acquired, under RCW 36.77.020.

Background: In 2019 the County completed the 84th Street NE Safety Study. The County proposes to construct a roundabout at the 84th Street NE and 123rd Avenue NE intersection to improve traffic flow and safety, consistent with the 2019 study. Community outreach completed to date includes mailers (2,600), project website: [84th St NE and 123rd Ave NE Intersection Improvements | Snohomish County, WA - Official Website \(snohomishcountywa.gov\)](https://www.snohomishcountywa.gov/84th-St-NE-and-123rd-Ave-NE-Intersection-Improvements), one-on-one coordination with 12 out of 12 parcels, and a public meeting held in November 2021. NEPA has been completed for the project.
