**Summary:** The ordinance approves grant agreement with Washington State Department of Agriculture (WSDA) for Evergreen State Fairgrounds. A grant has been awarded to the County for health or safety improvements to the agricultural fairgrounds and facilities. Grant Agreement No. K5048 in the amount of \$23,500, will be used for renovation of the sheep wash rack area, plumbing upgrades for goat and bovine wash racks, replacement of all door closers in the 604 event center, installation of two new glass ADA compliant entry doors, replacing old chain link panels in the livestock area, and adding high arch gates.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.

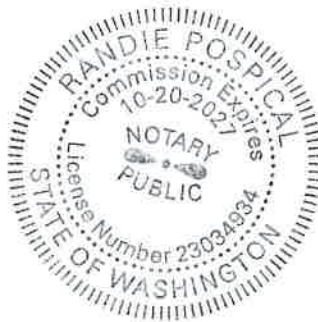
