PROPOSED ORDINANCE NO. 25-049  
AN ORDINANCE VACATING 90<sup>th</sup> AVE NW,  
A SNOHOMISH COUNTY ROAD RIGHT-OF-WAY

Background: Stillaguamish Tribe of Indians (the Petitioner) submitted Vacation Request # 23 116553 ROW to vacate unopened right-of-way (ROW) known as 90<sup>th</sup> Ave NW, located in Section 6, Township 31 North, Range 4 East, W.M. The County Engineer's Report recommends vacation provided the Petitioner pays for the cost and expenses associated with the vacation.

A summary of the proposed Ordinance is as follows:

Section 1. Adopts Ordinance recitals as findings.

Section 2. Finds that the unopened road ROW is useless for County road purposes and that the public will benefit from its vacation.

Section 3. States that the unopened road ROW described in Exhibit A and depicted in Exhibit B is vacated upon satisfaction of the terms and conditions contained in the Ordinance.

Section 4. Conditions the vacation upon the Petitioner's payment of the itemized costs and expenses under SCC 13.100.070 within one year of the adoption of this Ordinance.

Section 5. States that the Ordinance shall be recorded and effective upon confirmation that the Petitioner made the required payments. If the Petitioner fails to make the necessary payments within one year of the adoption, the Ordinance will become void and have no further force or effect.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.

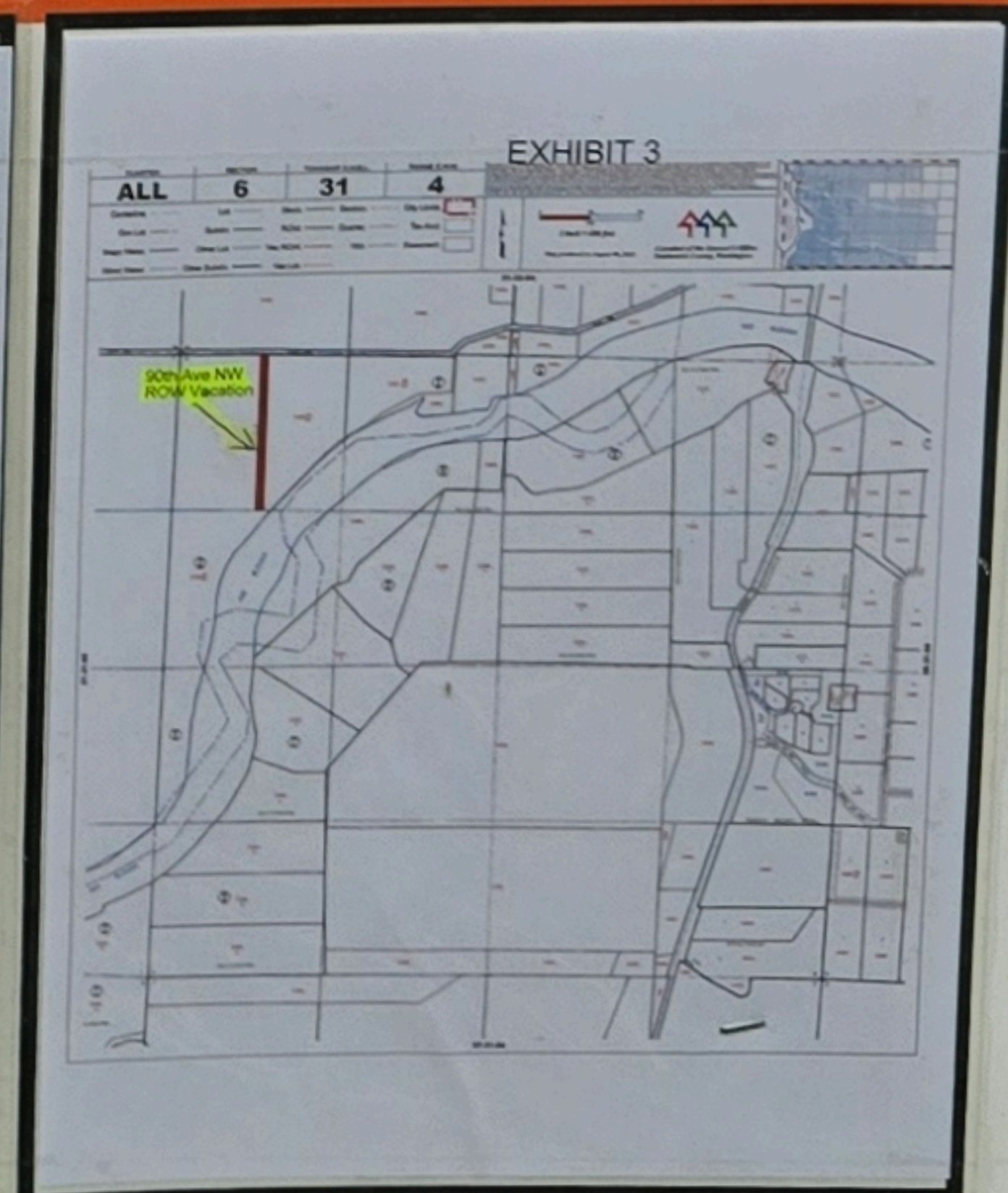
