Summary: The ordinance approves a data sharing agreement with the Washington State Department of Health for the County Health Department to quickly access information related to cases of multi-drug resistant carbapenemase producing organisms and *Candida auris*. Accessing the Collective Medical Technologies network will allow the Health Department to share information and conduct case investigations across public health jurisdiction lines. The term of the agreement is from execution through June 30, 2025.
