9 AUTHORIZING AN INCREASE IN CONSERVATION FUTURES TAX REVENUES  
10 FOR PROPERTY TAXES COLLECTED IN 2023



12 WHEREAS, the County Council held a public hearing on November 9, 2022,  
13 following public notice as required by law to consider the County's annual budget,  
14 including revenue sources for calendar year 2023, pursuant to RCW 84.55.120; and  
15

16 WHEREAS, the County Council, after hearing and duly considering all relevant  
17 evidence and testimony presented, including evidence and testimony presented upon  
18 consideration of proposed Ordinance No. 22-053, has determined that an increase in  
19 conservation futures tax revenue from the previous year, in addition to the increases  
20 resulting from the addition of new construction, improvements to property, newly  
21 constructed wind turbine facilities, and any increase in the value of state-assessed  
22 property under RCW 84.55.010, and from the refund provisions of Chapters 84.68 and  
23 84.69 RCW, is necessary in order to discharge the expected expenses and obligations  
24 of the County and in its best interests.

26 NOW, THEREFORE, BE IT ORDAINED, pursuant to RCW 84.55.120, that an  
27 increase in property tax revenues for taxes collected in 2023, in addition to the  
28 increases resulting from the addition of new construction, improvements to property,  
29 newly constructed wind turbine facilities, and any increase in the value of state-  
30 assessed property under RCW 84.55.010 and from the refund provisions of chapters  
31 84.68 and 84.69 RCW, is hereby authorized in the amount of \$42,623 for the 2023  
32 conservation futures levy, which is a percentage increase of one (1) percent from the  
33 previous year.


