**Subject:** FY2022 U.S. Department of Housing and Urban Development Continuum

of Care (CoC) Program Grant Agreement

**Scope:** Proposed Motion 23-386 authorizes the Executive to execute a contract

with The U.S. Department of Housing and Urban Development (HUD) for a contract totaling \$564,108. The grant total with match included is

\$705,135.

This project was included in the 2023 Human Services Department Grant Workplan in the amount of \$312,500<sup>1</sup>. The change in the grant total is

greater than \$50,000 and requires Council consideration pursuant to SCC

 $4.26.025^2$ .

All grant funds will be subcontracted to Volunteer of America to operate a transitional housing and rapid re-housing project. The project will

include five units of transitional housing and 12 rental units throughout

Snohomish County for homeless families.
