This document serves as Snohomish County's written notice of extension of the Original Agreement through July 31, 2026.
- 4. **Release of Assignor:** Upon execution of this Assignment and acceptance by the parties, Assignor shall be released from all obligations and liabilities under the Original Agreement arising on or after the Effective Date.
