Ms. Harper noted that she will follow up with information on additional proposed sites, and will request the Department of Emergency Management to provide a presentation at a future meeting.

Councilmembers expressed support of the recommended project priorities. Ms. Harper indicated that she will coordinate with GTH and Council on the next steps in the funding application process, including the drafting of joint letters of support, as needed.
