

AMENDMENT NO. 2 TO THE AGREEMENT FOR
PROFESSIONAL MEDICATION ASSISTED TREATMENT

This Amendment No. 2 To The Agreement for Professional Medication Assisted Treatment Services (“Amendment No. 2”), is entered into by and between Snohomish County, a political subdivision of the State of Washington (the “County”), and Ideal Option, a Washington Professional Limited Liability Company (“Ideal Option” or the “Contractor”).

WHEREAS, on August 20, 2020, the County and the Contractor entered into a Professional Services Agreement for Professional Medication Assisted Treatment (“Agreement”). The Agreement governs the terms by which the Contractor provides medication assisted treatment services and oversight to certain inmates housed in the Snohomish County Jail; and

WHEREAS, the parties wish to revise the Agreement’s hours of service and fee structure.

NOW THEREFORE, in consideration of covenants, conditions, performances, and promises hereinafter contained, the parties mutually agree to amend the Professional Services Agreement as follows:

1. Schedule B of the Agreement, shall be removed and replaced with a new Schedule B, included with this Amendment No. 2, and hereby incorporated by reference.
2. Except as expressly provided in this Amendment No. 2, all of the terms and conditions of the Agreement are ratified and affirmed and remain in full force and effect.
3. This Amendment No. 2 may be executed in counterparts, each of which shall constitute an original and all of which shall constitute one and the same agreement.


