APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE  
TO EXECUTE CRITICAL AREA SITE PLANS

WHEREAS, in the 2025 CIP the Snohomish County Council approved construction of the Heybrook Ridge Erinswood Trail; and

WHEREAS, in order to construct the project, a Critical Area Report (June 2023) was prepared identifying critical areas, buffers and mitigation related to the project to comply with SCC Chapter 30.62A; and

WHEREAS, SCC Chapter 30.62A requires permanent identification and protection of Critical Area Protection Areas to be left permanently undisturbed in a substantially natural state; and

WHEREAS, a portion of the project property was chosen for habitat protection adjacent to the trailhead and trail development; and

WHEREAS, in order to permanently protect the property, Critical Area Site Plans are required to be approved by the Snohomish County Council and recorded with the Snohomish County Auditor;

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves and authorizes the Snohomish County Executive to sign and execute the Critical Area Site Plans as attached hereto and incorporate by reference herein.
