6 ORDINANCE NO. 24-077

8 AUTHORIZING AN INCREASE IN ROAD TAX REVENUES  
9 FOR PROPERTY TAXES COLLECTED IN 2025

10  
11 WHEREAS, the County Council held a public hearing on November 25, 2024,  
12 following public notice as required by law to consider the County's biennial budget,  
13 including revenue sources for calendar year 2025, pursuant to RCW 84.55.120; and  
14

15 WHEREAS, the County Council, after hearing and duly considering all relevant  
16 evidence and testimony presented, including evidence and testimony presented upon  
17 consideration of proposed Ordinance No. 24-076, has determined that an increase in  
18 road tax revenue from the previous year, in addition to the increases resulting from the  
19 addition of new construction, improvements to property, newly constructed wind turbine  
20 facilities, and any increase in the value of state-assessed property under RCW  
21 84.55.010, and from the refund provisions of chapters 84.68 and 84.69 RCW, is  
22 necessary in order to discharge the expected expenses and obligations of the County  
23 and in its best interests;

25 NOW, THEREFORE, BE IT ORDAINED, pursuant to RCW 84.55.120, that an  
26 increase in property tax revenues for taxes collected in 2025, in addition to the  
27 increases resulting from the addition of new construction, improvements to property,  
28 newly constructed wind turbine facilities, and any increase in the value of state-  
29 assessed property under RCW 84.55.010 and from the refund provisions of chapters  
30 84.68 and 84.69 RCW, is hereby authorized in the amount of \$736,500 for the 2025  
31 road levy, which is a percentage increase of one (1) percent from the previous year.
