Section 1. Snohomish County Code Section 2.300.090, adopted by Amended Ordinance No. 22-061 on October 26, 2022, is amended to read:

There is hereby established a Snohomish county board of health, as directed by RCW 70.05.035. The board of health shall annually elect a chair and vice chair from its membership ((in January of each year)). The chair shall be one of the county councilmembers and shall preside at the meetings of the board of health.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
