11 APPROPRIATION IN FUND 100 TO INCREASE EXPENDITURE AUTHORITY FOR
12 THE PROSECUTING ATTORNEY TO COVER UNANTICIPATED LOSS OF REVENUE

15 BE IT ORDAINED:

17 Section 1. The County Council makes the following findings of fact: An
18 emergency appropriation of \$140,000 is necessary in the Community Impact (Special
19 Revenue) Fund 100, in the Prosecuting Attorney’s 2025-2026 budget, to increase
20 expenditure authority to absorb expenses creating a negative cash balance in Fund
21 118, Crime Victim Witness Fund caused by an unanticipated reduction in revenue.

23 Section 2. The appropriation details for the emergency appropriation are as

37 Section 3. The County Council further finds that there is a need for this
38 emergency appropriation to alleviate a negative cash balance in Fund 118, which was
39 created by an unanticipated level of reduction in revenue provided by the State for State
40 mandated services provided under Fund 118. The level to which funding would be
41 reduced was not known at the time Council adopted the 2025-2026 budget. The County
42 Council therefore finds that the need for the appropriation authorized by this ordinance
43 constitutes a public emergency that could not reasonably have been foreseen at the
44 time of budget adoption for 2025-2026 and hereby authorizes the appropriation.
