<u>Summary:</u> The ordinance amends Chapter 25.20.055 Snohomish County Code (SCC) to extend Lake Ketchum Restoration service charges for 5 years with a moderate increase in charges. Lake Ketchum previously suffered from chronic toxic algal blooms caused by high phosphorus pollution. Toxic algae blooms are a threat to public and environment health and as a result, public use and enjoyment of the lake are severely impaired. A summary is as follows:

Community Beach Lot	((\$35.00))\$40.00 per parcel of real property with an undivided ownership interest in lake front real property used for common beach access
