Authority Granted: Approve and authorize the County Executive to sign Professional Service Agreement CCF03-24 with Otak, Inc. for the amount of \$647,839.89, and further authorizes the Director of Public Works or designee to approve amendments up to \$64,783.99, provided that sufficient appropriation authority exists, for a total of not to exceed \$712,623.88, under SCC 3.04.140(11).

Background: The Pilchuck Creek Bridge #626 carries Old 99 N Highway over Pilchuck Creek, north of 236th Street NE, exit 210 to I-5. The existing bridge carries a two-lane road, classified as a Local Access (Rural) road with 428 vehicles per day (per 2018 traffic count). The existing 180-feet long, three-span bridge is structurally deficient and is to be be replaced with a new 180-feet long single-span bridge.

Snohomish County issued RFQ-24-007SB earlier this year seeking design consultant assistance for this project. Otak, Inc. was one of seven firms that responded and was selected through established Federal, State and County policies and practices. The replacement bridge is funded by Federal Highway Administration (FHWA), administered by Washington State Department of Transportation Local Programs.
