In May 2021, an initial Limited Notice to Proceed was issued to Strider Construction, Inc., this was in advance of receiving the executed Underpass Agreement with BNSF and allow for the procurement materials and perform administrative activities in advance of the work on the project with permit and BNSF timeline restrictions. A Full Notice to Proceed was issued to Strider Construction, Inc. on June 15, 2021.

To date a total of nine (9) Change Orders to the original contract have been approved by either the Executive or Council, including Motion 23-399 for an additional retaining wall at the ADA access road. The retaining wall will be built within the city of Edmonds, and as part of the building permit process for the city of Edmonds, an indemnification/hold harmless and acknowledgement of slope stability is required. A State of Washington Licensed Civil Engineer has prepared the required documents for the construction of the retaining wall and have been provided to the city of Edmonds for permitting and inspection.

Requested Action: To move to GLS on December 13, 2023, for consideration.
