Scope: The Area Agency on Aging (AAA) State/Federal Agreement funds case

management and adult day services for seniors. Other services include the Senior Farmers Market Nutrition Program, home delivered meals, education about safe use of prescribed and nonprescription medication,

and family caregiver support.

The Agreement total is \$18,583,172. The grant was included in the 2024 Human Services Grant Work Plan in the amount of \$16,394,054. The

grant total increased by more than \$50,000 and requires Council

consideration pursuant to SCC 4.26.025¹.

Snohomish County provides \$104,536 in General Fund match for this grant. State match is \$352,252 and match from providers and local

governments is \$375,714.

<u>Authority Granted:</u> Motion 24-341 authorizes the County Executive to execute the AAA State/Federal Agreement with the Washington State Department of Social and Health Services and any future amendments.

<u>Background:</u> Snohomish County Long Term Care and Aging (LTCA) provides community leadership on issues related to aging.
