Josh Dugan, Executive's Office, provided a presentation and a detailed update on the Health Department integration.

Councilmember Dunn echoed concerns from the Sound Public Health Foundation regarding their uncertainty about next steps and what their role is. She spoke further to helpful practices and noted that if he [Dennis Worsham, Health Department Director] has a debrief meeting, it would be helpful to continue in-person meetings and the frequently asked questions document. Councilmember Dunn also spoke to bargaining agreements and the need for a bigger labor negotiation focus. She requested to flag the need for another labor negotiator. Mr. Dugan said he wasn't aware of any future plans but thanked her for the feedback.

Councilmember Nehring requested a meeting to discuss rules of the Council, the new Board, and the Executive's Office, to make sure all are on the same page. Mr. Dugan said he would work with Mr. Worsham for a later discussion.

Dennis Worsham, Health Department Director, shared a presentation, introduced himself, and spoke about a successful integration to implementation.

### 3. 2023 Performance Audit Plan - George Skiles

Ms. Beazizo provided an introduction and background information. She explained that following discussion today, should an audit be selected, she would be asking Council for direction. Responding to Chair Mead, Ms. Beazizo said there are no timeline requirements to make a decision and explained the constraints would be with needing a new RFP and potentially a new contractor. The current performance auditor would have to be done in August.

George Skiles, Performance Auditor, provided a brief review of the proposed audit for the Human Services Department.

Councilmembers discussed their preferences and concerns, and Mr. Skiles responded to questions regarding options for the 2023 performance audit.

Councilmember Dunn expressed her concerns with an audit for Human Services. Councilmember Nehring expressed concerns with end results of any audit when the departments come to Council and ask for significant budget requests.

After further discussion, councilmembers agreed they could wait on an audit for Human Services. Councilmember Dunn requested an overview of what would be included in an audit for the Courts vs. Facilities.

Chair Mead provided closing remarks and suggested delaying this discussion a couple of weeks to make a decision. Councilmembers concurred.
