Snohomish County Code Section 2.95.020, last amended by 12 13 Ordinance No. 18-047 on July 30, 2018, is amended to read: 14 15 2.95.020 Definitions. 16 17 In this chapter, unless the context clearly requires of therwise. 18 19 (1) "arts commission" means the Snohomish county arts commission established 20 by SCC 2.95.010; 21 22 (2) "arts fund" means the fund created by SCC 2.95.080; 23 (3) "arts program" means the arts program established pursuant to SCC 24 25 2.95.050; 26 (4) "arts program administration" means staff responsibilities incidental to aiding 27 the arts commission in implementing this chapter; 28 29 (5) "the arts" means all visual and performing artistic media. Visual media 30 include but are not limited to drawing, tapestry, weaving, painting, mural, fresco, 31 32 sculpture, prosaic, photograph, calligraphy, collage, assemblage, artist made or 33 designed building parts, floor, wall or ceiling treatments, railings, corbels, lintels, 34 beams, benches, and structural or functional elements of a building or structure. 35 Performing media include but are not limited to music, theater, dance, storytelling, and performance art, and; 36 37 38 (6) "cost" of a county construction project means only the county-funded portion 39 of a county construction project, provided that the "cost" shall not include the cost 40 of real property acquisition, equipment or furnishings, and provided further that if **4**1 the source of construction funding or other applicable law precludes the arts as 42 an object of expenditure of funds, "cost" shall exclude the funds so precluded; 43 44 (7) "county construction project" means any project funded wholly or in part by 45 the county to construct or remodel any building, park or public space owned wholly or in part by the county, provided that such project has a cost of at least 46

\$100,000, ((but less than \$10,000,000)) and provided further that "county 1 2 construction project" shall not mean a project or portion of project involving 3 county public roads, surface water management, airport airfield or airport lease 4 related structures; and 5 6 (8) "works of art" mean products of the arts. Works of art may also include an 7 area or space specifically designed, constructed and managed as a display area 8 for visual media or a performance venue for performing media. 9 10 Section 2. Snohomish County Code Section 2.95.080, last amended by Ordinance No. 08-067 on May 7, 2008, is amended to read: 11 12 13 (1) The arts fund is hereby established 14 (2) The budget for each county construction project that has a cost of no more 15 16 than \$50,000,000 shall include an amount equal to 1% of the cost of the county construction project as defined in 2.95.020(6) and 2.95.020(7), which amount 17 shall be deposited in the arts fund from the funds identified in that budget. The 18 department responsible for the county construction project shall make or initiate 19 the deposit into the arts fund. The county finance committee shall develop a 20 policy that establishes the time and mapner for the making of these deposits into 21 22 the arts fund. 23 24 (3) The budget for each county construction project that has a cost of at least 25 \$50,000,000 may include an amount equal to 1% of the cost of the county construction project as defined in 2.95.020(6) and 2.95.020(7), which amount 26 shall be deposited in the arts fund from the funds identified in that budget. The 27 department responsible for the county construction project shall make or initiate 28 29 the deposit into the arts fund. The county finance committee shall develop a policy that establishes the time and manner for the making of these deposits into 30 the arts fund. 31 32 33 (((3))) (4) The county may in the budget ordinance provide for additional 34 contributions to the arts fund. 35 36 (44)) (5) Private or other public contributions to the county for the arts, including but not limited to grants, bequests and gifts, shall be deposited in the arts fund. 37 38 At the request of the donor, a contribution may be limited to a particular work or 39 works of art as approved by the county executive and county council acting by 40 motion. **4**1 42 (((5))) (6) Any other proceeds or revenues dedicated to the county arts program shall be deposited into the arts fund. 43 44 45 ((6))) (7) The costs of arts program administration may be paid from the arts 46 fund.

2	(((7))) (8) Amounts on deposit in the arts fund, less the costs of arts program
3	administration, shall be expended only on works or art recommended by the arts
4	commission and approved by the county executive pursuant to SCC 2.10.010
5	and thereafter approved by the county council pursuant to SCC 2.95.040(2).
6	Expenditures from the arts fund may be made to create works of art, to acquire
7	works of art, and to install, display, maintain or perform works of art. All
8	expenditures from the arts fund shall be subject to appropriation by the county
9	council.
