PROPOSED ORDINANCE NO. 25-025

APPROVING AND AUTHORIZING THE EXECUTION OF AN INTERLOCAL  
AGREEMENT BETWEEN SNOHOMISH COUNTY AIRPORT AT PAINE FIELD FIRE  
DEPARTMENT AND THE SNOHOMISH COUNTY EMERGENCY MEDICAL  
SERVICES AGENCY FOR SUPPORT FOR EMERGENCY MEDICAL SERVICES  
PROVIDERS IN SNOHOMISH COUNTY

**Summary:** Snohomish County Airport/Paine Field Fire Department, as an emergency medical agency in Snohomish County, wishes to enter into an Interlocal Agreement (ILA) as a member of the Snohomish County Emergency Medical Services Agency (SCEMSA). The ILA formalizes the relationship between SCEMSA and the Paine Field Fire Department to work together to enhance emergency medical services in the region. This agreement is part of a broader initiative to improve collaboration among cities, fire agencies, and private sector ambulance companies in providing high-quality EMS to residents and others living, working or traveling in Snohomish County. SCEMSA will provide support to the Emergency Medical Services providers in Snohomish County, Snohomish County 911, the Snohomish County EMS and Trauma Care Council, and the Medical Program Director.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
