CALL TO ORDER

ACTION ITEMS

 Ordinance 23-085, approving and authorizing the Snohomish County Executive to sign the Interlocal Agreement between Snohomish County and the Tulalip Tribes of Washington to Implement Portions of the Snohomish Cooperative Salmon Barrier Removal Project 2023-0957

Deb Bell, Sr. Legislative Analyst, provided a staff report. She said the proposed ordinance would authorize the Executive to sign a proposed interlocal agreement and also authorize the Director of Conservation of Natural Resources to execute amendments under the agreement. Ms. Bell provided details of the agreement and noted that Councilmember Low has proposed an amendment sheet. She explained the proposed amendment and said it is attached to the agenda, included in the ECAF packet [see link 2023-0957]. Ms. Bell noted that there is an error on the amendment sheet citing an incorrect agency and explained the correct agency should read the Tulalip Tribes of Washington. She requested the clerks correct this as a scrivener's error.
