Title

Crystalize remaining Snohomish pre-approved project dollars. Non-monetary Change Order.

Background and Justification

The purpose of this Change Order is to crystalize the remaining pre-approved project dollars (US\$122,084) for future project use.

Description of Changes

Remaining approved project dollars of US\$122,084 will be available for future Change Orders (where the future Change Orders will reference Change Order 16).

The Work Order rate may vary dependent on the individual Work Order under the following parameters:

- \$260 per hour for quotes provided at the end of 2024 (that are approved by Snohomish for Work Order creation within 90-days of Cayenta quote delivery).
- \$270 per hour for quotes provided in 2025.
- \$TBD per hour for quotes provided in 2026 and beyond at the Cayenta's prevailing standard hourly rate, effective from January 1 each year.

Cumulative dollars of all Change Orders approved by Snohomish are not to exceed the balance of US \$122,084, as jointly tracked by Snohomish and Cayenta.

NOTE: These dollars are NOT credits as they have never been invoiced to, nor pre-paid by Snohomish.
