8 RELATING TO THE 2024 BUDGET; MAKING A SUPPLEMENTAL APPROPRIATION IN  
9 PARKS CONSTRUCTION FUND 309 TO PROVIDE EXPENDITURE AUTHORITY FOR  
10 IMPROVEMENTS AT KAYAK POINT PARK

13 WHEREAS, Snohomish County accepted funding from Port of Everett for water  
14 quality improvements at Kayak Point Park through Motion NO. 23-377; and  
15

16 WHEREAS, the County received the Port of Everett funding after adoption of the  
17 2024 Budget; and

19 NOW, THEREFORE, BE IT ORDAINED:

21 Section 1. The County Council makes the following findings: A supplemental  
22 appropriation in the amount of \$450,000 is necessary to provide expenditure authority in  
23 Parks Construction Fund 309, for budget year 2024, to fund water quality improvements at  
24 Kayak Point Park.

26 Section 2. The appropriation unit and allocation detail for the supplemental  
27 appropriation described in Section 1 are as follows:
