Phase 1 of the proposed project, located in Council Districts 4 and 5, will widen the corridor between 187th St SE and 180th St SE from two lanes to three lanes and create new connections meeting urban standards such as bike lanes, curb, gutter, planters where feasible, sidewalk, ADA compliant curb ramps, a traffic signal at Sunset and 180th St SE, and a roundabout at SR524.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.




