

**AMENDMENT 3 TO THE SOFTWARE AS A SERVICE AGREEMENT BETWEEN
SNOHOMISH COUNTY AND MANATRON, INC. – AUMENTUM TECHNOLOGIES OR
AUMENTUM, FOR AUMENTUM TAX ASSESSMENT AND COLLECTION SYSTEM**

This Amendment 3 dated March 20, 2024 (the “**Effective Date**”), to the Software as a Service Agreement for the Aumentum Tax Assessment and Collection System between Snohomish County and Manatron, Inc. – Aumentum Technologies, executed on December 2, 2020; and amended by Amendment 1 on December 16, 2021, and Amendment 2 on September 27, 2023, (the “**Agreement**”), is made by and between Snohomish County, a political subdivision of the State of Washington (the “**County**”) and Manatron, Inc. – Aumentum Technologies, a Michigan corporation licensed to do business in Washington State, hereafter (the “**Contractor**”).

RECITALS

WHEREAS, the County and Manatron, Inc. – Aumentum Technologies are the parties to that certain Agreement executed on December 2, 2020, and amended on December 16, 2021 and September 27, 2023, entitled “SOFTWARE AS A SERVICE AGREEMENT BETWEEN SNOHOMISH COUNTY AND MANATRON, INC. – AUMENTUM TECHNOLOGIES OR AUMENTUM, FOR AUMENTUM TAX ASSESSMENT AND COLLECTION SYSTEM”; and

WHEREAS, the parties desire to remove functionality described in WASNO-UseCase81 WASNO-UseCase204 from the implementation scope of work as described in change request No. WA2019.002.01-CR02 (“CR02”); and

WHEREAS, the parties desire to certify the AddMaster printing device for use with Aumentum Platform for slip printing of receipts, validation and printing of excise stamps as described in change request No. WA2019.002.01-CR03 (“CR03”); and

WHEREAS, the parties desire to add development of an interface between Third Party Excise eFiling Vendors and Aumentum Platform as described in change request No. WA2019.002.01-CR04 (“CR04”); and

WHEREAS, the parties desire to add development of four (4) levy reports that were identified during the Fit – Gap Analysis Project and described in Assessor Use Case-111 Levy Reports as optional as described in change request No. WA2019.002.01-CR05 (“CR05”); and

WHEREAS, the parties desire to increase the “Name” field from 32 character limit to 64 character limit as described in change request No. WA2019.002.01-CR06 (“CR06”); and

WHEREAS, the additional cost to the Agreement for the work described in CR02, CR03, CR04, CR05, and CR06 is \$131,025.00, plus applicable sales tax.

NOW, THEREFORE, in consideration of the mutual obligations set out below, the parties agree that the Agreement is amended as follows:

1. WASNO-Use Case81/Title:Sales Review/Analysis (Systemic archiving and purging of sales records by date ranges) and WASNO-UseCase204/Title: GIS 4.19 (Use mapping system to perform various tasks) are removed from the scope of services.
2. Contractor shall:
 - a. Certify the AddMaster Model IJ7202-2C to work with Aumentum Platform, including

- modification to the Print Agent functionality to allow alignment and formatting codes to be communicated between Aumentum and the printer, as described in CR03;
 - b. Develop an interface between Third Party Excise eFiling Vendors and Aumentum Platform, as described in CR04.
 - c. Develop four (4) levy reports that were identified in the Fit Gap Analysis Project and described in Assessor Use Case-111 Levy Reports, as described in CR05;
 - d. Increase the “Name” field from 32 character limit to 64 character limit, as described in CR06.
3. Exhibit E-2, Total Cost Summary Schedule, is replaced in its entirety with Exhibit E.3 Total Cost Summary Schedule attached to this Amendment 3.

Except as expressly amended in this Amendment 3, the terms and conditions of the Agreement remain unchanged and in full force and effect.
