8 ORDINANCE NO. 25-019

10 DISSOLVING THE LOCHSLOY PILCHUCK FLOOD CONTROL DISTRICT
11 PURSUANT TO CHAPTER 36.96 RCW

14 WHEREAS, the Lochsloy Pilchuck Flood Control District (hereinafter District), is
15 a special purpose district governed by the laws of the state of Washington and subject
16 to dissolution in accordance with Chapter 36.96 RCW et seq.; and
17

18 WHEREAS, the Snohomish County Council held a public hearing on April 30,
19 2025, to consider evidence and testimony relating to the proposed dissolution of the
20 District;
21

22 NOW, THEREFORE, BE IT ORDAINED:
23

24 Section 1. The County Council adopts the following findings in support of this
25 ordinance:

- 26 A. The foregoing recitals are adopted as findings as if set forth in full herein.
27 B. The District has not held commissioner elections within the preceding
28 consecutive seven-year period.
29 C. The District has not carried out any of the special purposes or functions for
30 which it was formed within the preceding consecutive five-year period.
31 D. The District has never imposed assessments on properties within the District.
32 E. The district has no assets or liabilities.
33 F. Following the formation of the district, commissioners declined to proceed
34 with the proposed improvements and levying of assessments due to:
35 a. Estimated costs exceeding the district residents' ability to support the
36 necessary level of assessment.
37 b. The district's inability to obtain necessary permits for the proposed
38 improvements.
39

40 Section 2. The County Council makes the following conclusions:

- 41 A. The District is inactive pursuant to RCW 36.96.010.
42 B. It is in the public interest to dissolve the district based on the findings set forth
43 in Section 1 above.

Section 3. The County Council bases its findings and conclusions on the entire record including all testimony and exhibits. Any finding which should be deemed a conclusion, and any conclusion which should be deemed a finding, is hereby adopted as such.

Section 5. The Lochsloy Pilchuck Flood Control District is hereby dissolved pursuant to RCW 36.96.040.
