MODIFICATION OF THE SHERIFF'S OFFICE EXEMPT EMPLOYEES SALARY SCHEDULE

WHEREAS, SCC 3.68.050 provides that exempt employees of the Sheriff's Office shall be covered by the Sheriff's Office Exempt Compensation Plan, and the salary range shall be established by the Human Resources Director and approved by the County Executive and County Council; and

WHEREAS, in the past, compensation increases for Major, Bureau Chief, and Undersheriff have been determined based on maintaining ratios to the subordinate employees covered by the Sheriff's Office Management Team (SOMT) labor agreement; and

WHEREAS, the SOMT labor agreement has not been settled for this year, and due to the need for timely pay adjustments, an alternative approach to determining salary increases for these positions is required; and

WHEREAS, it is recommended that the Major, Bureau Chief, and Undersheriff receive a 3.63% Cost of Living Adjustment (COLA) aligned with increases provided to other non-represented staff; and

WHEREAS, the attached salary schedule establishes a new salary schedule to take effect on April 1, 2025, as outlined in Exhibit A;

NOW, THEREFORE, ON MOTION, the Snohomish County Sheriff's Exempt Employees Salary Schedules, attached hereto as Exhibits A, is hereby approved.
