MOTION AUTHORIZING THE EXECUTIVE TO SIGN AMENDMENT NO. 1 WITH  
SWEDISH HEALTH SERVICES TO PERFORM FOLLOW-UP WITH OVERDOSE  
PATIENTS UNDER THE CDC OD2A GRANT

WHEREAS, the Snohomish County, through its Health Department, were awarded the Overdose Data to Action: Limiting Overdose through Collaborative Actions in Localities (OD2A: LOCAL) grant through CDC; and

WHEREAS, the Health Department previously entered into an Agreement with Swedish Health Services to perform follow-up with overdose patients presenting at Swedish Health Services – Edmonds and Mill Creek locations; and

WHEREAS, Swedish Health Services will follow up with nonfatal overdose patients who were treated at their Emergency Department to connect patients with substance use and mental health treatment and other needed services; and

WHEREAS, these services are core public health services that the Snohomish County Health Department performs; and

WHEREAS, Swedish Health Services is a trusted voice in the community and the Health Department would like to continue this partnership; and

WHEREAS, Swedish Health Services and the Snohomish County Health Department have a current need to enter into an amendment to increase the not to exceed amount of the agreement by an additional \$32,000;

NOW, THEREFORE, ON MOTION, the County Council hereby authorizes the Executive to sign Amendment No. 1 with Swedish Health Services in substantially the form as that attached hereto as Exhibit A.

**AMENDMENT NO. 1 TO AGREEMENT  
BETWEEN SNOHOMISH COUNTY AND  
SWEDISH HEALTH SERVICES**

This Amendment No. 1 is made and entered into on the 1 day of September, 2024, between the SNOHOMISH COUNTY, hereinafter called "County," and SWEDISH HEALTH SERVICES hereinafter called the "Contractor."

WHEREAS, the Parties hereto have previously entered into an Agreement to perform follow-up with overdose patients presenting at Swedish Health Services – Edmonds and Mill Creek locations; and

WHEREAS, both parties desire to supplement said Agreement to amend the total amount and to extend the term of this agreement,

NOW THEREFORE, in consideration of the terms, conditions covenants and performance contained herein or attached and incorporated, and made a part hereof, the parties hereto agree as follows:

Each and every provision of the Original Agreement dated January 8, 2024, and entered into September 1, 2023, shall remain in full force and effect, except as modified below:

1. Amend Section 2 in its entirety. Term of Agreement: Time of Performance. This Agreement shall be effective upon September 1, 2023 (the "Effective Date") and shall terminate on August 31, 2025, PROVIDED, HOWEVER, that the term of this Agreement may be extended or renewed for up to two (2) additional one (1) year terms, or to a date as determined by Centers for Disease Control and Prevention, and Injury Prevention and Control Research and State and Community Based Programs, at the sole discretion of the County, by written notice from the County to the Contractor. The Contractor shall commence work upon the Effective Date and shall complete the work required by this Agreement no later than August 31, 2025, PROVIDED, HOWEVER, that the County's obligations after December 31, 2024, are contingent upon local legislative appropriation of necessary funds for this specific purpose in accordance with the County Charter and applicable law.
2. Reimbursement for this contract period (9/1/2024 – 8/31/2025) is not to exceed \$32,000.
3. Reimbursement for the total contract period (9/1/2023 – 8/31/2025) is not to exceed \$64,000.
4. The effective start date of this amendment is 9/1/2024.
5. All other terms and conditions remain unchanged.

IN WITNESS THEREOF, Contractor has caused this Amendment 1 to the Agreement, to be executed by its Executive Director and the County has caused this Amendment to be executed by its Executive, each of whom have authority to bind their respective entities.
