Consideration

The Executive's Office requests Council consider approving proposed Motions 22-103 and 22-104 which approve the nominations of Katrina Delplato and Susan Lakey to the Snohomish County Developmental Disabilities Citizen Advisory Board.

Background

The Snohomish County Council established the Developmental Disabilities Advisory Board (Board) by Ordinance 15-001¹ in February of 2015. The Board replaced the mental health program advisory board, a board which was established originally by Resolution in 1967.

The Board advises Snohomish County officials on the delivery of services through the developmental disabilities program. That program may deliver the following services:

- Coordinate the County's delivery of developmental disability services with other public, including state, and private services;
- Address community service and resource needs through grants, projects, training, technical assistance, and information;
- Provide information and referrals for people with developmental disabilities and/or their families and with the community at large; and
- Make comprehensive plans to develop local services.

The developmental disabilities program receives funds from governmental and public/private grants to support its program authority. The Board consists of not more than 15 members. The membership's composition pursuant to SCC 2.52.030 is to be as follows:

- 1 member from each council district;
- At least 5 members with developmental disabilities or with family members with developmental disabilities (community advocates); and
- Other members who are knowledgeable of or interested in community support for people with developmental disabilities and their families (at large).

Members are limited to serving three consecutive terms. Appointees who have served three consecutive full terms may be considered for appointment after one year of separation from the board.

Current Proposal

Scope:

Motion 22-103 confirms the appointment of Katrina Delplato. Katrina resides in Council District 5 and is the current Director of Operations at Bright Mosaic Autism Center with

prior experience in school districts, medical facilities, autism centers and in-home settings. This would be Katrina's first term.

Motion 22-104 confirms the appointment of Susan Lakey. Susan resides in Council District 2 and is currently a Pharmacist with Johnson and Johnson. Susan has advocated on behalf of individuals with developmental disabilities for over 20 years and also worked part-time in a group home with individuals with developmental disabilities. Susan has a son with a developmental delay and is seeking opportunities to engage in Snohomish County to continue support of individuals with developmental disabilities. This would be Susan's first term.
