<u>Authority Granted</u>: Motion 24-180 authorizes the Executive to sign Amendment No. 2 to a contract with Volunteers of America Western Washington for health literacy services.

Background: In Summer of 2022, Council took actions that initiated integration of the Health District into the County. On June 8, 2022, Council approved a Notice to withdraw from the Snohomish Health District through Motion 22-248¹, and on August 24, 2022, approved a Common Interest and Non-Disclosure and Joint Defense Agreement with the Snohomish Health District through Ordinance 22-030².

Requested Action: Move to GLS on May 22, 2024, for Council consideration.
