SNOHOMISH COUNTY BID SUBMITTAL FORM

The bidder, in compliance with the Invitation for Bid for the Weatherization Assistance Program, having examined the scope of work, terms and conditions, related documents, and being familiar with all of the conditions surrounding the work of the proposed project including the availability of material and labor, hereby proposes to furnish all labor, materials and incidentals, and to perform the work in accordance with the Contract Documents at the prices stated below. These prices are to cover all expenses incurred in performing the Work required under the Contract Documents, of which this bid submittal is a part.

1. **BID PRICES:** For ease of entry and calculation, an Excel spreadsheet is provided for bidders.
All Unit (measure) prices must be reported with three component costs: a) material cost, b) labor and overhead, and c) total measure price.
For measures with no materials involved, a single labor price is satisfactory.
2. **OVERHEAD AND PROFIT:** The undersigned agrees that all of the abovenamed base bid pricing include all contractor's overhead and profit or fee.
3. **SALES TAX:** Bid pricing shall not include sales tax. The County is not exempt from paying sales tax. Any sales tax required shall be included on all invoices.
4. **RIGHT OF REJECTION:** Bidder agrees that the County reserves the right to reject any or all bids, or the bid on any alternate, and to waive any informalities in the bidding.
5. **CONTRACT AND BONDS:** If the bidder is notified of award of this bid within sixty (60) days of opening bids, or any time thereafter before this bid is withdrawn, the bidder agrees to execute a contract for the bid work in the contract forms provided in this bid. Compensation shall be based on bid prices. Bidder agrees to furnish insurance and performance and payment bonds as required.
6. **ADDENDA:** Receipt of addenda numbered ____ throughout ____ is hereby acknowledged. Notifications of addenda posted will be sent out to all bidders that have downloaded this bid (plan holder) from the County's Purchasing Portal. Bidders should check the portal for addenda prior to submitting their bid. Failure of any bidder to receive addenda or interpretation shall not relieve any such bidder from any obligation under the bid as submitted.
7. **CONFLICT OF INTEREST:** The undersigned certifies and warrants that to the best of its knowledge and belief and except as otherwise disclosed, it does not have any personal or family relationship that may conflict with business or organizational conflict of interest, which is defined as a situation in which the nature of work under the contract and the bidder's organizational, financial, contractual or other interest are such that award of the contract may result in the bidder receiving an unfair competitive advantage, or the bidder's objectivity in performing the contract work may be impaired.

Disclose any potential Conflicts of Interest:
