The RHINO program is responsible for syndromic surveillance data collection in near real-time from hospitals and clinics from across the state, analysis, and distribution. Key data elements reported include patient demographic information, chief complaint, and coded diagnoses.



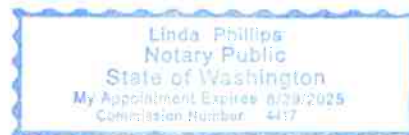
