Authority Granted: Approves and authorizes the County Executive to sign Amendment 4 to the Interlocal Agreement between Snohomish County and the Alderwood Water and Wastewater District concerning utility construction associated with the 36th/35th Ave West: 164th Street SW - SR 99 Road Project, under RCW 39.34.030 and SCC 13.01.020(5).

Background: Snohomish County has a public road improvement project (TIP #E.40.01) to improve the 36th/35th Ave West corridor from 164th St SW to SR 99. In January 2022 Snohomish County entered into an Interlocal Agreement with the Alderwood Water and Wastewater District which would allow the County to perform Utility Work (relocate water lines, etc.) on behalf of the district. To date the parties have processed three amendments, one approved by Council in May 2024, and two within the Council approved contingency amount, all to provide additional but related work that was not included in the original bid.

Requested Action: Move to GLS on December 18th, 2024, for consideration.
