A. Call to Order

Council Chair Mead called the meeting to order at 9:00 a.m. and provided instructions for those wishing to provide public comment in person and remote via Zoom.

The following individuals provided public comment:

- Linda Hjelle, resident of Granite Falls, League of Women Voters of Snohomish County, provided comments in support of preserving legacy forests in the fight against climate change.
- Gayle Leberg, resident of unincorporated Snohomish County, provided comments relating to mature forests and the need for a comprehensive plan to find replacement land before harvesting mature trees.
- Nancy Johnson, resident of Edmonds, provided comments in support of preserving mature forests and protecting endangered species.
- Kate Lunceford, resident of Bothell, League of Women Voters of Snohomish County, spoke in support of protecting legacy forests and the need to find replacement lands and opportunities to fight the climate crisis.
- Clara Hsu, resident of Edmonds, League of Women Voters of Snohomish County, provided comments in support of saving mature and working forests, which store carbon to help mitigate climate change.
- Karen Crowley, resident of Snohomish, League of Women Voters of Snohomish County, spoke about state legislation that provides tools for counties to find replacement lands and preserve mature forests.
- Brel Froebe, Center for Responsible Forestry, provided comments relating to state legislation to allow counties to enter into agreements for revenue sharing from the sale of timbers. He also spoke about a report of possible replacement parcels that he would provide to the Council.
- Mark Rhode, resident of Snohomish, provided comments in support of preserving mature forests and the importance of carbon sequestration.
