

AMENDMENT 8 TO CONTRACT FOR TURNKEY PUBLIC ACCESS PHONE SERVICES

This Amendment 8 to the CONTRACT FOR TURNKEY PUBLIC ACCESS PHONE SERVICES (“Contract”), executed on November 24, 2004, and previously amended by Amendment 1 on January 23, 2014, Amendment 2 on August 18, 2016, Amendment 3 on September 5, 2018, Amendment 4 on November 20, 2020, Amendment 5 on October 25, 2021, Amendment 6 on February 9, 2022, and Amendment 7 on August 29, 2022, is made and entered into this 23rd day of August 2023, by and between Global Tel*Link Corporation, d/b/a ViaPath Technologies, an Idaho Corporation licensed to do business in the State of Washington (the “Contractor”), and Snohomish County, a political subdivision of the State of Washington, (the “County”) (Contractor and County collectively, the “Parties” and each a “Party”).


NOW THEREFORE, in consideration of the promises and covenants set forth in this Amendment 8, and for good and valuable consideration, the sufficiency of which is acknowledged, that Parties agree as follows:

Section 1. The term of the Contract is extended for three (3) months from November 24, 2023, through February 23, 2024 (“Extension Term”). The Contract shall renew automatically in three (3) month terms through November 23, 2024, unless written notice is provided by the County to the Contractor at least sixty (60) days before the end of the then current Extension Term, PROVIDED, HOWEVER, that the County’s obligations after December 31, 2023 are contingent upon local legislative appropriation of necessary funds for this specific purpose in accordance with the County Charter and applicable law.

Section 2. In the event of any inconsistencies between the terms and conditions contained in the Contract and the terms and conditions contained herein, the terms and conditions contained herein shall control. Except as set forth in this Amendment, the Contract shall remain in full force and effect, without modification or amendment, and is hereby ratified and confirmed. This Amendment may be executed in multiple counterparts, each of which shall be an original, and all of which shall be one and the same contract. Original signatures transmitted by facsimile or electronic mail shall be effective to create such counterparts. Each person whose signature appears below warrants and represents that they have the requisite authority to execute this Amendment on behalf of the entity for which they are signing.
