APPROVAL OF AMENDMENT 1 TO AGREEMENT FOR LEAD AND RNP SERVICES  
WITH EVERGREEN RECOVERY CENTERS

WHEREAS, the Washington State Health Care Authority (HCA) awarded the County a deliverables-based grant of \$1,685,878 in June 2020 (administered by the Prosecuting Attorney's Office (PAO)), to implement a Law Enforcement Assisted Diversion (LEAD) Pilot Site Development program in Snohomish County to run through September 30, 2021; and

WHEREAS, the HCA awarded the County additional grant funds of \$1,612,000 in 2021 (administered by the PAO), to continue the LEAD program in Snohomish County for the period between October 1, 2021, through June 30, 2023; and

WHEREAS, the HCA awarded the PAO additional grant funds of \$1,612,000 in 2023 (administered by the PAO), to continue the LEAD program in Snohomish County for the period between July 1, 2023, through June 30, 2025; and

WHEREAS, the HCA has awarded the PAO additional grant funds of \$1,552,326 in 2025 (administered by the PAO), to continue the LEAD program in Snohomish County for the period between July 1, 2025, through June 30, 2027; and

WHEREAS, the North Sound Behavioral Health – Administrative Services Organization (North Sound BH-ASO) awarded the County a grant of \$512,455 in 2022 (administered by the PAO), to implement a Recovery Navigator Program (RNP), and to allow for the expansion of the LEAD program, for the period between January 1, 2022, and December 31, 2022 (subsequently extended by agreement and operation of contract through June of 2023); and

WHEREAS, the North Sound BH-ASO awarded the County a grant of \$645,000 in 2023 (administered by the PAO), to continue the RNP for the period July 1, 2023, through June 30, 2024; and

WHEREAS, the North Sound BH-ASO awarded the County a grant of \$645,000 in 2024 (administered by the PAO), to continue the RNP for the period July 1, 2024, through June 30, 2025; and

WHEREAS, the North Sound BH-ASO authorized an additional \$223,500 in 2024 to the County (administered by the PAO) in Reserve Funds in 2024, to support RNP for the period July 1, 2024, through June 30, 2025; and

WHEREAS, the North Sound BH-ASO has awarded the County a grant of \$411,826 in 2025 (administered by the PAO), to continue the RNP for the period July 1, 2025, through December 31, 2025; and

WHEREAS, the Bureau of Justice Assistance with the U.S. Department of Justice awarded the County a Comprehensive Opioid, Stimulant, and Substance Use Program (COSSUP) grant of \$1,200,000 (administered by the PAO) in 2021, to expand the County's LEAD program between October 1, 2021, through September 30, 2026; and

WHEREAS, the grant funds from the HCA, the North Sound BH-ASO, and the Bureau of Justice Assistance for these programs pass through the PAO's budget to Evergreen Recovery Centers (ERC) and have no fiscal impact on the PAO's annual operating budget in 2025 or 2026; and

WHEREAS, Snohomish County, on behalf of the PAO, entered into an Agreement for Professional Services with ERC to provide day-to-day case management services to LEAD Program participants on October 19, 2020, and has subsequently amended that contract on four occasions regarding funds available, scope of services, and periods of performance; and

WHEREAS, the County and ERC, entered into a new Agreement for Professional Services on December 15, 2023, to continue LEAD and RNP, that captures the operative provisions of, and supersedes, the prior Agreement and its amendments, and extended the term through June 30, 2024, and increased the total contract award to not exceed \$1,150,000; and

WHEREAS, the County and ERC agreed to Amendment No. 1 to the Agreement for LEAD and RNP Services that extended the term through June 30, 2025, adjusted the Scope of Services related to expansion efforts, and increased the total contract award to not exceed \$1,800,000, from July 1, 2024, through June 30, 2025; and

WHEREAS, the Snohomish County Council authorized the County Executive on October 17, 2025, to sign an Agreement for LEAD and RNP Services with ERC for the term July 1, 2025, through December 31, 2025, with the total contract award not to exceed \$835,000, from July 1, 2025, through December 31, 2025;

NOW, THEREFORE, ON MOTION, the Snohomish County Council authorizes the County Executive to sign Amendment 1 to the Agreement for LEAD and RNP Services with ERC that extends the term to June 30, 2026, and increases the total contract award to not exceed \$1,670,000.
