<u>Summary:</u> The current Apprentice program within Snohomish County Code (SCC) has been successful. The existing program will be utilized on the construction of all public works where the estimated cost of construction is over one million dollars. Any project where the estimated cost of construction is more than five million dollars will then use Priority Hire Requirements. The ordinance amends the existing Chapter 3.05 within SCC as "Chapter 3.05 Construction Projects – Apprentice <u>and Priority Hire</u> Requirements", and adds new definitions and Priority Hire Requirements.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.


