AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE TO SIGN CONTRACT AMENDMENT 7 WITH HILLIS CLARK MARTIN & PETERSON, P.S. FOR ENVIRONMENTAL LEGAL SERVICES FOR THE SNOHOMISH COUNTY AIRPORT

WHEREAS, long-term tenants of the Snohomish County Airport and other outside entities may have caused or contributed to hazardous waste, substances, pollutants and contaminants on Airport property in various locations; and

WHEREAS, by previous motions (20-254, 22-396, 23-088, 23-366, 24-238), the Snohomish County Council approved and authorized the County Executive to sign a legal professional services agreement with outside attorneys for consultation and specialized legal advice regarding the southeast area of the airport and tangential locations (Tect) at the Snohomish County Airport with Hillis Clark Martin & Peterson, P.S. ("HCMP"); and

WHEREAS, HCMP has continued to provide consultation and advice regarding the Airport in those locations; and

WHEREAS, HCMP has increased its attorney hourly rates for 2026 and 2027; and

WHEREAS, it is in the best interest of the County to amend the current contract for legal services from HCMP to reflect the increase in attorney hourly rates and increase compensation in amount not to exceed the following additional contract amount: not to exceed an additional \$80,000.00;

NOW, THEREFORE, ON MOTION, the Snohomish County Council authorizes the County Executive to sign Amendment No. 7 (Tect) to the current HCMP Agreement for Legal Services in the form attached hereto.

### AMENDMENT NO. 7 AGREEMENT FOR LEGAL SERVICES

This AMENDMENT NO. 3 (the “Amendment”) is made by and between SNOHOMISH COUNTY, a political subdivision of the State of Washington (“County”), and HILLIS CLARK MARTIN & PETERSON P.S., a Washington Professional Service Corporation (“HCMP”) for the Snohomish County Airport in and around the southeast area of the airport and tangential locations at the Snohomish County Airport (the “Matter”). In consideration of the mutual benefits and covenants contained herein, the parties agree as follows:

1. Attorney Allyson C. Bazan at HCMP is specifically added in each of the contract provisions to include: Section 1, Scope of Services; Section 3, Compensation; Section 4, Appointments as Special Deputy; Section 5, Associate Counsel and Experts; and Section 22, Notices.

2. Amendment to Section 3.c of the Agreement. Section 3.c., Compensation, of the Agreement is amended with the following term: The total charges for services and other matters provided by the Attorney under this Agreement during the term of this Agreement is increased by \$80,000.00 (Eighty Thousand Dollars), which shall not be exceeded without prior written authorization of the County.

3. Addendum B, Rate Schedule, is updated to reflect rates for 2026 and 2027.
